THE CLINTON RIVER WATERSHED COUNCIL OFFERS A VARIETY OF PROGRAMS AND SERVICES THROUGHOUT THE WATERSHED. EVENTS INCLUDE RIVER DAY AND CLINTON CLEAN-UP. RIVER DAY EVENTS ENCOURAGE VOLUNTEERS TO TAKE ACTION AND CELEBRATE THE RIVER AND THE WATER ENVIRONMENT. ACTIVITIES INCLUDE STREAM BANK RESTORATION, NATIVE PLANT INSTALLATION, INVASIVE SPECIES REMOVAL, RAIN GARDEN INSTALLATION, STORM DRAIN STENCILING, CLEAN UP ACTIVITIES, WATER QUALITY MONITORING DEMONSTRATIONS, PUBLIC STORMWATER EDUCATION AND MUCH MORE. CLINTON CLEAN-UP HAS OVER 200 VOLUNTEERS THAT COLLECTED 5 TONS OF TRASH, TIRES, BUILDING MATERIALS AND OTHER DEBRIS.

THE PURPOSE OF THE PROGRAM IS TO ASSIST COMMUNITIES IN PREPARING THEIR EDUCATION REQUIREMENTS FOR THE PHASE II PERMITS FOR THE STATE OF MICHIGAN.

WE GRADUATE OVER 4,500 STUDENTS A YEAR THROUGHT THIS PROGRAM. ADOPT-A-STREAM HAS 360 VOLUNTEERS COVERING 50 MONITORING SITES. THIS PROGRAM IS DONE TWICE A YEAR. CRCCP HAS OVER 100 VOLUNTEERS WHO WORK ON PROJECTS THAT PROMOTE RESTORATION ON THE PAINT CREEK TRIBUTARY TO THE CLINTON RIVER.
